




COP 15



In May 2009, the Polish Minister of Culture and Heritage, **Bogdan Zdrojewski**, launched an open, international competition in two phases to find the design for the Polish History Museum in Warsaw. The museum, covering **20 000 sq. m.**, will be built in the **Jazdow district** near the banks of the Vistula and the vast, prestigious parks that are an integral part of the city's identity.

The jury appreciated the **elegant and minimalist proposal** by the team Paczowski & Fritsch that, without receding into banality, enables a vast flexibility of the space and the possibility for a wide variety of museological installations.

YE QING WINS DESIGN PRIZE

Chinese architect Ye Qing, member of the UIA work programme on architecture and renewable sources of energy (ARES) was awarded the **Beijing Institute of Architecture Prize** for architectural design during a ceremony commemorating the Institute's 60th anniversary. This prize recognizes the exceptional **energy performance qualities of the new IBR Shenzhen office building**.

**ADVENT: 18 EXEMPLARY PROJECTS**

Created in 2007, the Advent project's main objective is to encourage better energy performance in the ventilation of non-domestic buildings. Nikos Fintikakis represented the UIA as a specialist consultant in the creation of this project.

Eighteen exemplary realisations were identified in Europe. The **energy performance levels of their ventilation and air-conditioning systems were evaluated** and the descriptions were edited in electronic format. The final document is available for download from the ARES Work Programme's website.
