Kevin Bingham is the Managing Director of the award winning FGG Architects Inc. based in Durban, South Africa. He serves on the South African Council for the Architectural Profession, where he chairs the Education and Recognition of Prior Learning (RPL) Committees, and serves on the international Canberra Accord executive. A former president of the South African Institute of Architects (SAIA) and the regional SAIA-KZN, he has represented South Africa on numerous UIA bodies, including the Council, Professional Practice Commission and the Public Health Group. After three decades in architectural practice and academia, both locally and internationally, he is today principally interested in exploring the relationship between infectious diseases and architecture, including studies at the Harvard School of Public Health.

Dr. Huang Xiqiu (China) is a practicing architect and professor of architecture. Graduate of the Department of Architecture, Southeast University in Nanjing, China, he earned his doctorate from the Catholic University of Leuven in Belgium and was a visiting scholar in the Department of Architecture at the Faculty of Engineering at Tokyo University in Japan. He is currently Chief Architect Consultant for China IPPR International Engineering Company Limited, where he is in charge of 200 health-related planning and design projects, has edited 10 national standards for the health sector, and published 60 articles on the subject of design and health. He is a member of the Architectural Society of China (ASC) and of the UIA Public Health Group.



Hanaa Dahy (Egypt /Germany) is a practicing architect, professor and researcher. She graduated with a B.S.c in Architectural Engineering from Ain Shams University in 2003 and went on to obtain a Masters in Architectural Engineering from the same institution in 2006. She finished her Doctoral studies in 2014 from the University of Stuttgart. Founder of Stuttgart University's BioMat department, she also founded ArchIDA (Research Center for Architecture in Stuttgart) and is a Principal Investigator at the Clus- ter of Excellence in Stuttgart, "Integrative Computational Design and Construction for Architecture". Winner of several international awards, she holds numerous sustainable building material patents and is currently establishing a research centre in Denmark, BioMat@Copenhagen.



Cliff Harvey (Canada) is a practicing architect specialised in healthcare design. As a senior architect at the Ontario Government, and Senior Hospital Executive, he collaboratively leads the planning, design and implementation of capital infrastructure projects using advanced management methods for complex projects and building holistically upon governance, strategy, project management, planning, design, and procurement policies. An international expert on health and design, he is currently the Chief Planning Officer for Niagara Health, and is leading the development of the new South Niagara Hospital. He is today acting Director of the UIA Public Health Group (UIA-PHG), a Founding Director of the Canadian Centre for Healthcare Facilities (CCHF), and also serves as Chair and Vice-Chair on a number of Canadian Standards Association (CSA) committees.



Dr. Nirit Pilosof is an architect, researcher, and healthcare design consultant. A fellow of Cambridge Digital Innovation (CDI) and Associate of Cambridge Judge Business School (CJBS) at the University of Cambridge, she is also a lecturer at the Coller School of Management at Tel Aviv University, where she teaches healthcare design at the MBA level in the Health Systems Management programme. She possesses post doctorate degrees from the Technion - Israel Institute of Technology, McGill University and the Center for Health Design in the United States. As a project manager at leading Israeli and Canadian architecture firms, she won international awards, including the Academy of Architects for Health Award from the American Institute of Architects (AIA), the American Hospital Association (AHA) graduate fellowship and the Azrieli Foundation fellowship.
