INTRODUCTION

The UIA recognises that for architecture to truly benefit and reflect society's needs it must be inclusive of and empathetic to all who use it,

Friendly and Inclusive and universal design (also sometimes referred to as accessible design or design for all) aims to remove barriers that create undue effort or segregation and to achieve sustainable buildings and places that are user-friendly, accessible and understandable for everyone.

Organised by the UIA Work Program Architecture for All, the UIA Friendly and Inclusive Spaces Awards were established to encourage and acknowledge architects who have created exemplary friendly, inclusive and accessible buildings and public spaces. Entries must demonstrate that they have met the highest standards of universal and inclusive design, where the completed buildings and places contribute to the quality of life of all those who may use them.

A research award will also be given for evidence-based design research that makes a significant contribution to improved quality of life through facilitating a better understanding of human centred design and its application to the design of the built environment.

Special exhibition for nominated projects, space or research of any era in the host City, which exemplifies the aims of the Friendly and Inclusive Spaces Awards, eligible within any of the any of the award categories will be exhibited at the Congress. This is an enduring recognition to be nominated at each Congress for initiative in the Host city.

1. New Buildings
2. Refurbished Existing Buildings, including Historic Buildings
3. Public and Open Spaces
4. Research

ELIGIBILITY

Members of the Organiser's team, the jury/boards and their associates, business partners, employees, students and close relatives are not allowed to submit entries. Any person who has been involved in the preparation of the award/prize is not eligible to participate or to assist any participant.

Built works must have been completed since 30th November 2020 and may be submitted by the lead architect of the project or by the building owner/client with the architect's permission. Attribution must be correctly presented and agreed in submission when there are number of architects in a team. Projects that have previously been submitted may be submitted only one additional time.

Research by an architect or architects which advances the theory and practice of friendly and inclusive design must have been completed since 30th November 2020. Projects that have previously been submitted may be submitted only one additional time.

EVALUATION CRITERIA

- **Categories 1, 2 and 3**

Entries will be evaluated on the overall quality of design and how the project has addressed accessibility and inclusive design. In particular, the Jury will consider whether the quality of the architecture:

1. Improves the user experience through use of friendly scale, form, colour, material, light and sensory characteristics
2. Facilitates usability, orientation, navigation, wayfinding, ease of understanding, dignity, respect and safety for all.
3. Exhibits inclusion of the breadth of human diversity. (Submissions should clearly explain and demonstrate the approach and design thinking behind the scheme and how the principles of inclusive design were planned for and integrated.)

- **Category 4**

1. Contributes to improved quality of life through facilitating a better understanding of user centered and inclusive design and its application to the design of the built environment
2. Can be applied widely and used effectively by architects and others to enhance design quality and create friendly and inclusive places



SUBMISSION

Deliverables

For Categories 1,2 and 3

- Access and Inclusion Statement - max. 500 words describing how the project responds to the evaluation criteria. And address the following questions:
 - Question 1: How did you ensure the design process was inclusive of diverse user needs, including those of people with disabilities, older adults, and other marginalized groups
 - Question 2: In what ways does the project go beyond regulatory accessibility requirements to create a truly inclusive and welcoming environment? Which standards did you use?
 - Question 3: Did you work with accessibility consultants during the design process? If so, how did their contributions influence the outcome?
 - Question 4: If you have user involvement, can you describe how users or community members were involved in the design, development, or evaluation of the project? What impact did their input have?
- Client or User Comments – Max 100 words
- User involvement in the design process is encouraged especially, including people with lived experience.
- Drawings: Site plan, floor plans and cross sections to fully illustrate the project in PDF format only.
- Photographs: Maximum of 15 in jpeg format only, up to 5MB per item
At least three photographs should show the project in context, the remaining should give a comprehensive overview of the project.
Photographs should be labelled – Project name [photo number] photographer name.jpeg
Minimum of two photographs should be identified as your preferred Publicity Shots (PS).
They should be labelled PS – PS Project name [photo number] photographer name.jpeg.

When notified only Medallists and Honourable Mentions are required to submit a 3-minute video for public presentation of their projects.

For Category 4.

- Access and Inclusion Statement - max. 1000 words describing how the project responds to the evaluation criteria.
- Client Comments max 100 words
- User Comments – max 100 words
- Dissemination impact
- Link to the research document



OFFICIAL LANGUAGE

- The official language for the award and submissions is English.

AUTHOR'S RIGHTS

All submitted material shall become the property of the UIA. The author of any entry retains the copyright and the author's rights of the submitted work. Award participants must guarantee being the authors of the submitted project/work and not infringing intellectual property rights of third parties.

Publication rights: Participants give the right to the UIA and the Architecture for All Work Programme and Member Sections to publish the submitted material (images, illustrations, photos etc.) of the entries for the purpose of promoting the award, its aims and for research. The UIA may publish the entries on its website, in exhibitions, press releases, social media, publications and other communications. The names of the authors will be mentioned. Award winners agree to mention the UIA Friendly and Inclusive Spaces Award whenever possible when presenting their project in the future.

AWARD PROCESS

For Categories 1 – 3

The nomination and evaluation process will be carried out in two (2) phases.

Nomination phase:

- Regional Nomination Panels, comprising members of the UIA Architecture for All Work Programme will evaluate the entries and make recommendations to the main international jury.
- The Regional Nomination Panels may be asked to review projects from regions other than their own.

Awarding phase:

- Recommended projects will be evaluated by an International Jury chaired by the UIA Honorary President.
- Nominated projects will be further evaluated by the International Jury who will vote for a global medal winner and Honourable Mentions in each Category.

- The jury awards shall be final and sovereign; decisions of the jury are not subject to reconsideration by the Organisers, in whole or in part, and binding on all parties concerned and decisions cannot be appealed against.
- Winners will be notified of the Competition results directly.
- A list of awarded projects will be posted on the UIA website and promoted to media outlets.



EXHIBITION AND PROMOTION

- The Organisers have the right to publicise entries and naming the authors.
- All winning and commended projects will be displayed at the 2026 Congress, promoted through publication on the UIA and Architecture for All Work Programme websites, social media and/or journals as well as those of UIA member bodies. Press releases publicising the winners will also be sent to international media.
- Winners will be required to submit a 3-minute videos of their winning Project.

AWARDS

- The Jury may award a Medal to the Global Winners in each of the 4 Categories, together with up to 3 Honourable Mentions in each Category.
- There are no winners at regional level.
- The Jury will publish a jury-report of its deliberations concerning the commended entries and the winners in each category and reserves the right not to make any award if, in its opinion, no entry reaches the required standards.

AWARD CEREMONY

- Global Medal Winners will be invited to present their project in person at a seminar organised by the Architecture for All Work Programme at the UIA Barcelona World Congress.
- Date 28/06/2026 - 02/07/2026.
- Registration fee, accommodation and travel cost for one representative of each category winner, will be provided by the UIA AFA Work Programme.
- Friendly and Inclusive Spaces Awards medals and certificates will be presented at the Barcelona UIA Congress.
